

Message from the President

Dear Friends,

This year was full of significant milestones for the Springfield Foundation. Our dedication to philanthropy and community betterment was on full display as we achieved remarkable accomplishments.

As I reflect more deeply on the impact we've had, I am reminded of a few standout achievements. Firstly, the Foundation received \$12.6 million in charitable gifts. These generous donations enabled us to distribute \$4.8 million in grants and awards, including \$686,000 in scholarships to over 400 students. Additionally, we approved funding for 100 projects through our discretionary grant program and we celebrated our 75th Anniversary with a Gala at the Hollenbeck Bayley Center. Attended by over 250 guests, this celebration was a testament to our longstanding commitment to community engagement. In addition to these achievements, we initiated a multi-year grant to address the mental health crisis devastating our young people. We also provided financial support for the new Global Impact Stem Academy "Upper Academy" located on the campus of Clark State.

Here is a summary of all we have accomplished with our donors, partners and community leaders:

- Opened 23 new funds.
- Distributed \$4.8 million in grants.
- Received 123 discretionary applications.
- Collected over \$58,000 in the Partners in Philanthropy campaign.
- Launched a new software platform, including the GoFund Online Donor Portal.
- Co-created a collaborative group dedicated to reducing youth violence, securing a \$1.6 million technical assistance grant to address gun violence.
- Selected a new initiative supporting a joint mental and behavioral health project with Rocking Horse Community Health Center, dedicating \$375,000 towards the school-based health clinic at Springfield High School.
- Provided over 200 local students with coats, hats, and gloves through a Winter Coat Drive supported by our donors, board, and staff.
- Board and staff participated in fitting students with new gym shoes through Shoes for The Shoeless.
- Staff volunteered throughout the year at various events, including the Summer Arts Festival, Springfield Cancer Center, Dayton Children's Hospital, the Pink Honor Walk, Kenwood Elementary School, the Children's Garden at Snyder Park, and the Jazz and Blues Festival.
- Attended the Mental Health and Wellness Fair at Clark State College, providing information about scholarships and FAFSA.
- Participated in Clark County College Night hosted by the Clark County School Counselors and OACAC.
- Said goodbye to departing Trustee, Jeanne Lampe, who has made invaluable contributions to the organization.

It's easy to count our accomplishments, but our work has had an immeasurable impact on the Springfield community. This is a direct result of your collective commitment to the Springfield Foundation and the dedication and generosity each of you bring to the table. I'd like to thank the staff for their invaluable contributions this year, and I'd like to thank board members in advance for your continued support under the leadership of Steve Moody. As my time on the Board of Trustees comes to a close, I look forward to the continued success of the Foundation in the years to come!

Creating Lasting Impact

In 2023, the following donors partnered with the Springfield Foundation to create **permanent endowment funds** in our community. These new funds will have an impact forever and will each build upon our shared lives and passions.

Aleena Umerani Scholarship Fund

This fund will provide scholarships to applicants that demonstrate financial need with a preference for Clark County Residents.

BarBK Endowment Fund

This endowment fund goes to Autumn Trails Stable for unrestricted use.

Baughman Ag Scholarship Endowment Fund

This scholarship fund goes to graduates of Graham High School majoring in Agriculture with a minimum 2.5 cummulative GPA.

Darlene Carpenter Pet Rescue Fund

This fund goes toward supporting programmatic expenses related to no-kill shelters, rescues, and training programs.

Darlene Carpenter First Generation College Scholarship Fund

This deferred fund will provide scholarships to first generation college students demonstrating significant financial need.

Dr. Henry Jud ("Hank") Memorial Fund in Support of the Gammon House Interpretive Center

This memorial fund will go toward the Gammon House for the design and build of the Gammon House Interpretive Center.

Elva Hampshire Scholarship Fund

This fund will provide scholarships to graduates of Greenon High School majoring in Mathematics.

Enon-Greenon Alumni Association Scholarship Fund

This fund goes to graduating seniors from Greenon High School.

Friends of Clark County Parks Endowment Fund

This fund supports the vision and mission of those who created and developed the Clark County Park District.

George E. and Sandra M. Ward Endowment Fund

This endowment fund goes to the American Cancer Society and Kirkmont Presbyterian Church in Beavercreek, OH.

Helen J. Brumfield Alpha Eta Chapter (DKG) Scholarship Fund

This fund will provide scholarships to Clark County graduates with recommendations determined by an external committee of Alpha Eta Chapter.

Joanne K. Schmidt Foundation for the Preservation of Global Wildlife

This endowment fund is to be equally distributed to the African Conservation Fund and the Tusk Trust for unrestricted use.

Marcia Frank Fund

This fund goes to the following organizations: the Nehemiah Foundation, Clark County Public Library, Clark County Historical Society, Springfield Museum of Art, Springfield Symphony Orchestra, Springfield Youth Symphony, Springfield Arts Council, the Ohio State School of Music, Wright State School of Music, Clark County Animal Welfare League, and the Delta Omicron Foundation.

McCoy Lewis Scholarship Fund

This scholarship fund goes to graduates in Clark County pursuing any form of higher education.

Nancy W. Henderson Endowment Fund

This fund supports the Springfield Symphony Orchestra, Springfield Museum of Art, Springfield Arts Council, and the Gary Geis Dance Company.

Ray, Mildred and Terry Group Family Fund

This family fund is for enriching the quality of life for residents of Pike and Bethel townships.

Scruse Family HBCU Scholarship Fund

This deferred fund will provide scholarships to African American high school graduates who attended Springfield City Schools, had a minimum 3.3 cummulative GPA, and who are attending a Historically Black College or University (HBCU).

Springfield Burying Ground Endowment Fund

This endowment fund provides unrestricted support for the charitable or educational purposes of Springfield Burying Ground, Inc.

Steve and Vicki Fourman Endowment Fund

This deferred fund will support graduates of Shawnee High School, majoring in music, Ohio University Marching 110 Student Support Fund, the Springfield Arts Council's Summer Arts Festival, and the Clark County Historical Society for genealogy expenses.

Triad High School Scholarship for Higher Education in Agriculture

This fund was founded by the McDavid family, who aim to ignite generosity and impact through giving back. The fund will award to graduating seniors from Triad High School who demonstrate a passion for Agriculture and will major in it.

Weixelbaum Memorial Fund

This memorial fund is unresricted and will support the most critical challenges that face the Clark County Community.





Clark State Performing Arts Center

The Clark State Performing Arts Center has been a recipient of a generous Springfield Foundation Grant for the last 16 years. In those years, the Performing Arts Center has been able to provide low-cost tickets to our events to ensure that everyone in our community can afford to attend shows at the Performing Arts Center. Too often, the live arts are considered only for the wealthy. We know that an entire community benefits from the live arts, not just the wealthy. The Springfield Foundation has been instrumental in helping us ensure that everyone in our community can attend. In the last 16 years, the Performing Arts Center has been able to offer 41,904 low-cost tickets to patrons who may not have otherwise been able to afford to attend. Most recently, the Performing Arts Center presented the *360 All Stars*.


Also, the Performing Arts Center offered workshops for youth with the Springfield Foundation Grants. We have been able to connect professional touring artists with youth in our community. They have offered workshops in basic acting, improvisation, self-expression, self-esteem building, and much more. Recently, actors from Aquila Theatre Company were performing at the Kuss Auditorium, and they held a workshop for youth at the Juvenile Detention Center. This kind of workshop was made possible by the Springfield Foundation grants we have received.

The Springfield Foundation has been a steadfast partner in the Performing Arts Center's quest to make sure the live performing arts is available for everyone in our community.

Warder Literacy Center

I have been at the Warder Literacy Center for 23 years. During that time, we have gone from a mostly communitybased organization to a full-blown one. And we have had several community-based foundations support faithfully all of those years, not the least of which is the Springfield Foundation.

For at least 19 of those years, we have been the recipient of a grant for our Adult Basic Literacy Education program. Finding funding for adults who have either graduated in "name" only or have dropped out is not easy. Not only do they often have the same educational challenges they faced as children, now they also have other life responsibilities, like jobs and/or their own children. Also, they often have developed coping strategies that are counter-effective for learning. All of this means that success rates are hard won, and it will take time to see educational gains. Not surprisingly, many see this as a lost cause. Despite this, we never have and neither has the Springfield Foundation!

You have heard the story of the man, facing countless stranded starfish, taking the time to throw those he could back into the sea. His heart is our philosophy! Each one can reach one and together we can turn the page on low literacy. The successes have been tangible: over 20 students have gotten their GED's, others have been able to find better employment opportunities, several have enrolled in higher education, and more than a few have returned to enroll their children in our program.

Thank you to the Springfield Foundation for sticking by us so that we have been able to persevere with our adult students, year after year.

Springfield Family YMCA



Grantee Stories: Human Services



Goodwill Easterseals Miami Valley

The Springfield Foundation and Goodwill Easterseals Miami Valley (GESMV) have a long history that spans 15 years. The Foundation has supported GESMV with grant funding that has helped provide critical services to community members throughout Clark County.

The WORDS program (now known as Radio Reading Service), is one of the many GESMV programs that have received funding. This is a radio reading service that offers 24/7 reading of publications, of all types, to those with vision loss and other disabilities.

Another program that has received funding for several years is GESMV's Child Screening Service with Early Childhood Mental Health program. This program identifies children under age five who are at risk or show signs of developmental delays and behavioral health needs, providing support that benefits their developmental, as well as short and long-term educational outcomes. The screenings take place either in person, in childcare centers, or online using the Ages and Stages Questionnaire. When a developmental delay, risk of delay, or mental health need is detected, the Child Screener communicates the results with the child's caregiver(s),teacher(s), and/or pediatrician. The Child Screener makes early interventions and behavioral health referrals to facilitate long and short-term support.

In recent partnership with Miami Valley Child Development Centers (MVCDC), GESMV has piloted a Therapeutic Intervention Preschool (TIP) classroom at the MVCDC location on East John Street in south Springfield. The TIP classroom provides hands-on support for children with more significant mental health needs. This model allows for more one-on-one instruction as well as more frequent developmental assessments. Under TIP frameworks, children who would never otherwise succeed in the mainstream school system are taught the skills they need to succeed in these settings. No other preschools in the area provide intervention services at this level.

Together the Springfield Foundation and Goodwill Easterseals Miami Valley are working to make it possible for all people to live, learn, work, and play with full inclusion in the life of the community.

Garth Q. Briggs Scholarship Fund of the Tecumseh Education Foundation

Established on July 25, 2007, the Garth Q. Briggs Scholarship Fund, created by the Tecumseh Education Foundation, Inc., has proven to be a remarkable asset for local students. Funded through a generous gift from the estate of Garth Q. Briggs, this endowment has provided substantial support to graduates of Tecumseh High School. *The primary focus of the fund is to offer scholarships to students, with financial need, pursuing vocational or technical education.*

Since its inception, the endowment fund has awarded a total of \$1,486,125 to 301 recipients. The impact of these scholarships has been significant, helping numerous students achieve their educational and career goals.

When we received the \$2.3 million for the Briggs fund in 2005 and we chose to invest with the Springfield Foundation, not in our wildest dreams could we have imagined that 19 years later we would have given out close to \$1.5 million and still have a balance of \$2.6 million!!! Needless to say, the Tecumseh Education Foundation Board is very pleased with how the Springfield Foundation handles this account!!

Tom Loftis made a significant impact during his tenure on the Springfield Foundation Board, which began in January 2012 and spanned three consecutive 3-year terms. His dedication to the organization was evident through his extensive service on committees, projects, and strategic planning. Tom's nine years on the Finance Committee showcased his ability to navigate complex finances, providing invaluable insights into the organization's fiscal health. He further dedicated eight years to the Investment Committee, demonstrating a keen understanding of prudent investment strategies. Tom's commitment extended to Board Governance for one year, where he helped steer the organization's strategic direction.

In addition to his committee work, Tom contributed his expertise to two ad hoc committees. Tom's contributions extended to several Boards, including Robbins & Myers, National Trail Parks & Recreation District, SpringForward, and the Greater Springfield Partnership (Chamber). His active participation in the Greater Springfield Moving Forward Parks and Recreation Committee and the Greater Springfield Housing Alliance underscored his commitment to community development. Professionally, Tom's affiliations with Midland Properties, Mother Stewart's Investor, and Residential Developments highlighted his dedication to improving local housing and infrastructure. Furthermore, his involvement with funds like the Walter S. Quinlan Foundation, along with his support for the Springfield Burying Grounds Fund, showcased his commitment to philanthropy.

Tom's outstanding contributions to the community were recognized in 2020 when he received the prestigious Dick Kuss Lifetime Community Achievement Award from the Greater Springfield Partnership, a testament to his unwavering commitment to making Springfield a better place for all its residents.





Catalyst of Change Award

This new distinguished accolade is bestowed upon a local nonprofit, individual, or group that, through their unwavering dedication, not only creates opportunities but also serves as a dynamic force for DEI within our community – both in their daily endeavors and beyond.

The purpose of creating this award was not only to show how committed we are to these efforts but to highlight and motivate



the leaders in our community to also find the value in DEI practices and how it can help boost and develop a richer, more vibrant community. This year's award recipient will serve as a catalyst for change, motivating others to become agents of positive transformation. As a small token of our appreciation, the DEI Committee presented a \$250 grant and this award in honor of their work.

The **Springfield Museum of Art** took it to heart when they learned that the Springfield Foundation was requesting funded organizations to create and adopt a DEI statement. After thoughtful planning, a thorough process, and meaningful feedback, their board and staff approved the following:

Art belongs to all people. The Springfield Museum of Art embraces Diversity, Equity, Inclusion, and Accessibility because art and the community thrive on openness to ideas and people, regardless of background, belief, or circumstance. As a dynamic, ever-evolving Museum, they intentionally pursue an understanding of their responsibility to be a space that reflects both the world they wish to live in and the vital role they seek to fill in their community. Together, they are stronger.

The Springfield Museum of Art has sought to infuse the spirit of their inclusivity statement throughout their work. Institutionally, they created a Diversity, Equity, Accessibility, and Inclusivity action plan. They then used their statement as a directional beacon in the development of their newly adopted strategic plan, infused the spirit of inclusion into the design of their soon-to-be complete renovation, and increased the diversity of their board and committees. Programmatically, they have deepened their offerings across their region, from the 500 preschoolers who visit each year to partnerships with Clark County Developmental Disabilities and McKinley Hall Treatment Center, as well as programs for adults with dementia and Alzheimer's. They commit to supporting community events that celebrate the diversity of their community, and through exhibitions, they seek to share underrepresented stories such as *Mirror Mirror*, an exhibition of contemporary female artists, *Really Free: The Radical Art of Nellie Mae Rowe*, the award-winning exhibition *BLACK LIVES as subject MATTER II*, and *Art Noire*, a celebration of Black excellence.

They recognize that this change is not a destination, but a continual journey toward improvement. A banner with "Art Belongs to All People" now hangs at the entrance to the Museum as a reminder of their commitment to inclusion and equity, as well as that everyone belongs at the Springfield Museum of Art and that art belongs to us all. The Springfield Museum of Art Executive Director, Jessimi Jones, was presented with the Catalyst of Change Award.



Investment Overview

A majority of the Springfield Foundation's endowment funds is invested in a "Balanced Pool" portfolio, which is structured for long-term total return. To provide diversification and to reduce overall risk, the investments are divided into carefully defined asset classes. Assets are invested by professional money managers hired by the Foundation through a competitive process. The investment performance of each money manager is monitored by an independent investment consultant retained by the Foundation and overseen by the Foundation's Investment Committee. A list of our current investment managers is available at our office.


